

#### EBIMS master plan... (from the start)



- To establish a body that will validate the qualification of internists at the European level in the form of a European Certificate in Internal Medicine.
- To establish an End-of-Training (formative assessment) exam that along with the European Certificate in Internal Medicine will lead to a European Diploma of Internal Medicine.
- To develop methods of formal and professional accreditation of training centres in internal medicine as defined by the curriculum.
- To develop a faculty development program to further education in internal medicine.
- To foster continuing medical education and professional development (CME/CPD).



# One board: two concepts, two time-limits, several desirable speeds

#### One board: two concepts



- The importance of implementing European strategies from a practical/pragmatic point of view.
  - European exam: what are we examining? For what?
  - European Internal Medicine passport (inside Europe is redundant; outside Europe?)

- The need for a comprehensive agreement on what should be done at a national level in order to homogenise the understanding and practices related to Internal Medicine
  - National vs European training programs;
  - What influence do national societies have in the training and final accreditation of specialists?






#### Internal Medicine in Europe...

#### What sets Internal Medicine apart?

- Is Internal Medicine a concept or a practice?
  - The "know it all specialist paradox"

• Sub-specialities, new specialities or curriculum-based referral centres

• How can we be (more) useful? Where do we really make a difference?




#### Internal Medicine at its core

- Where do we really make a difference?
  - Differential diagnosis
  - Complex patients/therapies

- Are special units more effective when run by internal medicine doctors?
  - Stroke, Cardiac insufficiency? (the difference between cv and activity/task!)
  - If so, why? How much does it have to do with training within the speciality?
  - Is Internal Medicine a "teaching speciality?"

## What to do first? Priorities and precedences

#### Upcoming activities and projects for EBIM



#### Over the first year:

- EU Curriculum Revision in Internal Medicine
- Launch of the European Exam in Internal Medicine (EEIM)

#### Over the second year:

- Start the accreditation and certification of training centres in Internal Medicine
- Quality Assurance and Harmonization of Training

#### Over the third year:

- European Internal Medicine Passport (internal)
- Propose criteria to accept Internal Medicine specialists from outside Europe

#### What would we like from EFIM? (wishful thinking)



#### Over the first year:

 To determine the regulatory differences and level of influence of each national society

#### Over the second year:

Bilateral recognition of an effective European coordination by EFIM

#### Over the third year:

- CV and consequent exam to be of the responsibility of each national society
- Work towards a more homogeneous cv at the country level
- Help define policies for accepting specialists (and interns) from outside Europe

#### Final comments



 The definition of an unified curriculum in Europe will be a major break through in the recognition and validation of the importance of Internal Medicine. The implementation of an unified strategy will always imply the creation of a standard evaluation across borders.

 A possible route is the identification of centres that may become a reference in the training of our speciality. These centres will have the responsability to provide support to other units and promote the development of Internal Medicine at a clinical, research and institutional level in each country.

#### However:




 None of these objectives can be reached without the involvement of the different national societies. In fact, the national societies must be active players in this process!
