Moreover, EFIM continued its commitment to excellence in education through the successful organization of both the Winter School in Björkliden, Sweden in February and the Summer School in El Escorial, Spain in June as well as the organisation of the 18th Clinical Research Seminar by FDIME in Paris in October. These educational initiatives provided participants with unique opportunities for professional development, skill enhancement, and networking with peers and experts in the field of internal medicine. I am also delighted to report that the European Journal of Internal Medicine (EJIM) has seen a significant increase in its impact factor, reaching an impressive 8.0 in 2023. This accomplishment is a testament to the high-quality research published in the journal and the dedication of our Editor-in-Chief, Prof. Giancarlo Agnelli, our editorial team reviewers, and authors.

Furthermore, I would like to welcome personally our two new members: Royal College of Physicians of Edinburgh, RCPE and the Mexican College of Internal Medicine who joined EFIM during the GA held in Athens.

Lastly, I am pleased to announce the launch of a call for new clinical working groups dedicated to four critical areas of healthcare:

- Acute Medicine and Hospital Medicine WG
- Diabetes and Obesity WG
- Heart Failure WG
- Infectious Diseases in Internal Medicine WG

Our Clinical Working Groups will be designed to bring together healthcare professionals, researchers, and experts who share a common interest and commitment to enhancing patient care and advancing the field of internal medicine. I encourage all members to actively participate and contribute their expertise to these vital initiatives.

As we celebrate these achievements, I would like to reaffirm our commitment to the mission and values of EFIM to strive for excellence in patient care, education, research, and advocacy, ensuring that EFIM remains at the forefront of shaping the future of internal medicine in Europe.

The European Board of Internal Medicine is pleased to share the progress in two critical areas:

- the European Exam for Internal Medicine
- and the revision of the European Training Requirements of Internal Medicine.



During the last 12 months, the European Board of Internal Medicine (EBIM) has completed a tendering process to procure a provider for their project to find a host for the European Exam for Internal Medicine. This has been done with the full support of both the executives of EFIM and UEMS. After a call for submissions to meet the requirements laid out in the tendering documents, eight proposals were received for consideration. Following a review of these applications, four were invited to present to EBIM. From the final two organisations, a final decision was made to appoint the Royal College of Physicians of Ireland RCPI) to proceed to a contractual negotiation.

As we move forward, plans are underway to establish an exam board, standard setting, and question writing groups. Through a call to the National Societies of Internal Medicine, individuals have been identified to form these groups and will be called upon when the process of developing the exam moves into an active phase. This will happen when the terms of reference between EFIM and UEMS are completed and a contract with the RCPI is signed.

Revision of the ETR of Internal Medicine

Recognizing the need to adapt to the evolving landscape of healthcare, EBIM has initiated the revision of the European Training Requirements (ETR) of Internal Medicine. Since its adoption in October 2016, it has become apparent that updates are necessary to ensure its relevance and effectiveness in preparing future internists. To this end, we have assembled a diverse group of 32 delegates from 15 National Societies of Internal Medicine, including representatives from the Young Internists, to contribute to this important endeavour. Together, these delegates have identified fourteen key areas for consideration in updating the curriculum:

- ✓ Bedside skills/Point of Care Ultrasound
- Community Engagement/Medical Misinformation/Social Media
- Diagnostic and Therapeutic excellence/ Management reasoning
- Nutrition
- Simulation and Serious Gaming
- Wellness of Trainees
- Interprofessional Training/Collaborative Practice/Other Specialties Comanagement/ Transition of care
- Medical Ethics
- Multimorbidity/Deprescribing/EoL Decision Making
- Diversity, Equity, and Inclusivity
- Digital Literacy/Digital Health
- Medical Leadership
- Adolescent and Gender-sensitive Care
- Green and Sustainable Medicine

Each topic has been allocated to a dedicated group tasked with proposing revisions for consideration.

Our working group commenced its efforts in October 2023, with a targeted goal of presenting a draft of the revised curriculum to UEMS and EFIM for feedback by late 2025. Subsequently, we aim to formally present the revised curriculum for adoption at the UEMS Council in April 2026.

EBIM is committed to fostering excellence in internal medicine education and practice across Europe, and we are grateful for the continued support and dedication of our colleagues, EFIM and UEMS.







8TH EFIM DAY

The 8th EFIM Day was held at the Holiday Inn hotel in Brussels on Friday 13 October gathering together 55 participants from 23 national societies of EFIM from Europe and outside sharing experiences and exchanging ideas.

Prof. Ricardo Gomez Huelgas, EFIM President and EFIM Executive Committee were delighted to welcome and address all the Presidents and the Society representatives.

Prof. Gomez Huelgas presented the activities and achievements following the ECIM 2023 congress in Athens and thanked all the representatives for their active contribution. New initiatives and projects were presented including the launch of new Clinical Working Groups, upcoming re-elections/elections at the GA in Istanbul and the call for interest to host ESIM Summer School in 2025 – 26/27.

Updates were given on the progress of the ECIM 2024 in Istanbul as well as personal address was delivered by Prof. Agnelli on the new impact factor of the journal reaching IF 8.00 and general progress of EJIM.

Highlight of the meeting was the keynote address by Nathalie Moll, EFPIA Director General, who delivered a compelling presentation that focused on access to innovative drugs, pharmaceutical innovation, public health, and healthcare policy. Her speech addressed the critical role of pharmaceutical companies in advancing healthcare and EFPIA's contributions to improving patient outcomes.

Engaging discussions covering a wide range of topics related to internal medicine, patient care, on a national level were discussed during the presentations of the national societies. We had the pleasure to learn more at this meeting from the Dutch Society, French Society, German Society, Norwegian Society and the Romanian Society and we would like to thank the Presidents for delivering the presentations. These sessions allowed participants to exchange ideas and best practices and address critical issues in internal medicine in Europe. We will repeat this once again next year when other countries will be invited to present.

Prof. Rijk Gans informed the participants on the progress of the European Exam of Internal Medicine and the selected supplier to organise the exam, RCPI; as well as the collaboration between EFIM and UEMS through EBIM.

We would like to thank all our participants for their active participation and contribution during the meeting working towards our shared goals of advancing internal medicine across Europe and beyond.

The next EFIM Day will take place on 18 October 2024 in Brussels.














Elsevier is pleased to announce excellent progress across key metrics for the European Journal of Internal Medicine (EJINME) in 2023. EJINME has experienced growth in its impact factor, improved its ranking in the internal medicine category in Clarivate, and received increased submissions. EJINME continues to publish highly relevant and widely read content.

Submitted and Accepted Articles by Country in 2022:




Article flow:

In 2023, there was a notable 33% increase in submissions compared to 2022. The rejection rate remains high at 85%, with 74% of articles being rejected without peer review. This resulted in 308 accepted manuscripts, including 175 research and review articles. The majority of accepted articles continue to originate from Italy and Spain. Notably, for the third consecutive year, China accounted for the largest number of submissions to EJINME with 1024 submissions, but experienced a rejection rate of 96%, resulting in only 43 accepted articles—equivalent to the number accepted from Spain. Italian authors demonstrated the highest success rate, with 122 out of 251 submitted manuscripts (48.6%) accepted for publication in 2023.

EUROPEAN JOURNAL OF INTERNAL MEDICINE REPORT 2024

The editorial handling times remained competitive, with a submission-to-first-decision time of 5 weeks and a submission-to-online-publication time of around 9 weeks in 2023. These swift editorial processes continue to be an impressive and influential factor for authors considering publication in EJINME.


Since 2020, EJINME has operated exclusively online. The journal's complete content is available for access and download across multiple platforms. It's important to mention that the download statistics listed in the table below include ScienceDirect HTML views and PDF downloads, as well as views and downloads from www.ejinme.com and Clinical Key. Overall, the usage performance in 2023 demonstrated strong engagement across all platforms once again.

Top Journal Titles Ranked by 2022 Impact Factor (including EJINME):

The Impact Factor for 2022 in the JCR Science edition has risen from 7.749 to 8. Additionally, the journal has advanced in ranking from 26th to 24th out of the 327 journals listed in the MEDICINE, GENERAL & INTERNAL category of JCR. EJINME maintains its position in the first quartile of this category. This exceptional performance in Impact Factor underscores the high quality of the journal and should be leveraged to enhance promotion among prospective authors and stakeholders.



As anticipated last year, the number of manuscripts submitted has slightly decreased as a result of COVID-19 tapering off. Yet, the number of submissions remained higher than the pre-pandemic period, with **433 case reports** received in 2023. In view of this slower trend, particularly noticeable at the beginning of 2023, we took particular care in monitoring actual costs in order to secure the journal's sustainability, and eventually achieved a positive economic result.

EJCRIM continued to uphold its **rapid peer-review and publication process**, with an average of 6 days to reach a decision and 5 weeks from submission to publication, comprehensive of language editing, which is provided free of charge by the journal. The editorial process was further tailored to guarantee a high-quality standard.

The journal's reach also expanded further, with USA leading the chart as the primary contributor of submissions (133 articles) and readership (about 9,850 users). Nonetheless, the acceptance rate of US articles was only 30%, suggesting a lower quality of their articles compared to other countries.

EJCRIM overall **rejection rate slightly increased to approximately 60%**, while maintaining a steady flow of published articles of approximately 10-12 papers per monthly issue without backlog.

CiteScore 2022, which includes all citations received in 2019-2022, **was 1.7** and **CiteScore tracker 2023**, which keeps on updating on a monthly basis, is **2.1**, showing an increasing trend with 1730 citations over 842 published items (last update 05 March 2024, source Scopus).

In order to enhance user experience and highlight the growing number of citations, noticeable enhancements have been made to the **website**, including the addition of some metrics such as visibility, downloads, and citation counters. Additionally, new staff members with professional expertise and background in biomedicine have been recruited.

Each issue table of content (e-toc) is announced monthly **newsletters**. In 2023, they were delivered to about 9,000 subscribers and reported a 50% opening rate. In addition, the **EJCRIM Facebook** page provides visibility to each article published in the journal, to reach the EJCRIM community who may not subscribe to the e-toc.

As per the past ECIM events, an **EJCRIM Best Case Report Competition** was held at the 21st ECIM Congress in Athens, Greece, with a dedicated session in the programme. The journal also supported the Best Case Report Competition at the 8th McMaster International Review Course in Internal Medicine (MIRCIM) on 11–13 May 2023 in Kraków, Poland with great success. Finally, the **Abstract Book** of the 21st ECIM Congress was edited and published online after the ECIM Congress as a Supplement of the Journal.

ECIM 2023 REPORT

The 21st European Congress of Internal Medicine, (ECIM) joint with the 12th International Congress of Internal Medicine, (ICIM) took place at the Megaron Conference Centre in the historic city of Athens from 15 – 18 March 2023.

For over 1450 specialists representing 74 countries from all around the globe, who had submitted 1712 abstracts, the congress provided this opportunity. This years' theme "Internal Medicine – A Bridge Between Health and Disease", highlighted the prevention, diagnosis, treatment, and compassionate care of adults across the spectrum from health to complex illness.

The four-day programme was built around 105 sessions and lectures given by experts in Internal Medicine as well as 30 Poster Discussions and poster viewings. All in all, the Congress showcased seven pre-congress workshops, seven plenary sessions, twenty-eight parallel sessions (doubling the number from last year), three round tables sessions, eleven rapid-fire sessions, 4 controversies debate sessions. The successful formats of joint sessions with several international associations were repeated this year as well, showcasing eight successful and interesting sessions. This has guaranteed a memorable congress, enabling the participant to actively participate in the debates and discussions in the latest updates in Internal Medicine with a prominent scientific faculty.

Following the tradition started during the 20th edition of the Congress in Malaga 2022, this year the ECIM Lifetime Achievement Award was given to Prof. Nica Cappellini, Italian Society of Internal Medicine, SIMI and Prof. Shoenfeld, Israeli Society of Internal Medicine.


This year's Congress edition also showcased a new change in the format: the poster exhibition was done with physical posters again.

The scientific programme was awarded 25 European CME credits by the European Accreditation Council for Continuing Medical Education (EACCME). It proved to be a truly international and successful event.











Appraisal of Guidelines in Internal Medicine Working Group

Chair: Wiktoria Lesniak

In 2023 Appraisal of Guidelines in Internal Medicine Working Group continued its work on adaptation of existing Clinical Practice Guidelines on:



- Acute heart failure management in internal medicine department the work was completed and the paper published
- * Treatment of hyperglycemia in internal medicine department the paper is under final revisions.

Additionally, the list of future guidelines topics was prepared by the WG members (including atrial fibrillation, electrolyte abnormalities, exacerbations of chronic obstructive pulmonary disease, identification and management of frailty-sarcopenia in elderly patients, inflammatory bowel disease, pharmacological management of obesity, rehabilitation of acutely admitted patients, secondary arterial hypertension, sepsis, thromboprophylaxis in hospitalized medical patients, urinary tract infections, vaccinations for elderly patients) so that the participants of ECIM in Istanbul could choose their preferred topics.

The following specific actions were carried out in 2023:

Meetings

- many regular online meetings of Acute Heart Failure Task Force (chaired by Prof. Valentin Kokorin and Dr Álvaro Gónzalez-Franco) took place to finalize the adaptation
- many regular online meetings of Hyperglycemia Task Force (chaired by Prof. Ignacio Marin-Leon) took place to finalize the adaptation
- An annual hybrid meeting of the WG chaired by Dr Wiktoria Lesniak with 12 members of the WG took place on 17th March 2023 during ECIM in Athens and the action plan and the objectives for 2023-2024 were discussed and agreed

- a webinar "Community acquired pneumonia -An EFIM guidelines critical appraisal adaptation for internists" released in EFIM Academy

Choosing Wisely Working Group

Chair: Omar Kherad

In the year 2023, the EFIM CW working group convened in Athens during the annual conference. The theme of deprescribing was discussed with two international

experts who presented clinical studies confirming the importance of integrating deprescribing to enhance the quality of care. Dr. Emily McDonald, from Montreal General Hospital, presented a deprescribing tool (Medsafer), and Prof. Omar Kherad presented a clinical study that led to a reduction in benzodiazepine prescription in the hospital setting.

This year was primarily marked by a change in presidency within the CW WG. Following an internal vote, Prof. Omar Kherad was elected president of the group, replacing Prof. António Vaz Carneiro. We thank the latter for the excellent work accomplished in recent years.

Meetings

EFIM- Choosing Wisely WG Athens 2023-Annual congress.

Action Plan for Next Years

- First workshop during ECIM in Turkey in 2024 about the role of healthcare in the climate crisis.
- Publication of a position paper from the EFIM CW working group by identifying possible actions for individual clinicians to address their contributions to healthcare's climate impact.
- Discussion about a list of intervention that may reduce burn out in hospitals (creation of a top five list)
- Labelling hospital among EFIM members that respect the CW recommendation to reduce Inappropriate transfusion practices. Hospitals would receive EFIM recognition for those efforts and become a designated Using Blood Wisely Hospital.

Multimorbidity Working Group

Chair: Máximo Bernabeu-Wittel

The EFIM multimorbidity has been active this past 2023. We are currently composed by 19 members from 16 scientific societies linked to the EFIM.

In the second year of walking together we have continued our collaborations with EFIM activities (in congresses and other events) and have carried our own training, research and positioning activities as a corporation in the clinical, health and social paradigm of multimorbidity in Europe.

Our group has taken part in the ECIM 2023 in Athens, organizing two sessions entitled: 'Competences of internists in the management of multimorbidity' (Chair – Máximo Bernabeu-Wittel), and 'Patient with diabetes is a patient with multimorbidity. What is more important: glucocentrism or cardiorenal protection' (Chair – Michal Holecki).

In the training activities we have continued with our collaborations with the EFIM Academy. We have conducted both a spring- and an autumn webinar in 2023 available on EFIM website, one dedicated to the topic: Coordination of Care and the other one focusing on Diabetes and Chronic Kidney Disease. We are finishing the work for the implementation of an on-line course dealing with practical aspects of managing patients with multimorbidity, which counts with five modules.

In the area of research during 2023, we have conducted the inclusion of patients of our first multicenter project to determine the impact of polypharmacy in patients with multimorbidity admitted to internal medicine or geriatrics departments (project led by Dr Václavik). Finally, more than 3700 patients from more than 35 centers have been included. We are now analyzing this relevant dataset.



Quality of Care and Professional Issues Working Group

Chair: Luis Campos

Context

The activities in the previous year were harmed by the long uncertainty about who was going to take over the Chairing position of the WG and also by the low proactivity of the members of the WG. In the end it was decided for Prof. Luis Campos to remain the Chair of WG in the absence of candidates until a suitable candidate was found to take over the Chairing position of the Professional Issues WG.

Several new members have joined the WG in the course of 2023 and some of the past members stepped down as representatives from their national societies.

Webinars

On the 18th of January 2023, the WG organized a webinar about "Nocebo in Internal Medicine". It was moderated by Dr. Maria Mylona and speakers were Dr. Petros P Sfikakis, Dr. Dimos D Mtsikostas and Dr. Evrydiki Kravvariti.



During the Annual Congress held in Athens, in March 2023, the WG organized a Pre-congress course on: What internists should know about the health impact of climate change? The Pre-congress course was presented by Prof. Luis Campos, Prof. Mine Durusu and Prof. Zeynep Komesli.

Conferences

Several members of the WG presented at conferences and participated in courses in national and international congresses, including the ECIM 2023.

Planned Activities

The WG is already working on several planned activities for the course of 2024 including upcoming webinars, podcasts in collaboration with EFIM Academy, surveys and articles.



2023 / ANNUAL REPORT /

Telemedicine, Innovative Technologies and Digital Health Working Group

Chair: Ismael Said Criado

This year has been marked by significant progress in our mission to promote the use of technology to improve healthcare delivery in internal medicine.

In March 2023, the WG underwent a leadership change with the election of a new coordinator during the European Congress of Internal Medicine (ECIM 2023) held in Athens.

Publications and Research:

The WG is proud to announce the completion of the EFIM Position Paper on Telemedicine. This document, authored by members of our WG and other experts, offers a comprehensive perspective on this rapidly evolving area of medicine. While publication is still pending, the paper is poised to make a significant contribution to the discourse surrounding telemedicine.

We were also thrilled to see the publication of our collaborative effort in the prestigious European Journal of Internal Medicine (EJIM) in June 2023. This publication (Filomena P, Sebastian K, Kati K, Tiffany L, Ismael SC; EFIM Telemedicine, Innovative Technologies and Digital Health Working Group. Telemedicine in internal medicine: A statement by the European Federation of Internal Medicine. Eur J Intern Med. 2023 Jun;112:138-139. doi: 10.1016/j.ejim.2023.02.021. Epub 2023 Mar 3. PMID: 36872139.) highlights the WG's commitment to advancing knowledge and disseminating best practices in telemedicine.

Furthermore, the WG embarked on a research initiative to gain deeper insights into the current state of telemedicine across Europe.

Collaboration and Knowledge Sharing:

The WG actively sought opportunities for collaboration throughout 2023 and played the role of guest editors for a thematic issue of JMIR Medical Education focused on "Digital Health Skills and Competencies for Clinicians and Health Care Professionals."

Engagement at ECIM 2023:

Our presence at the ECIM2023 conference was marked by a presentation on the EFIM Telemedicine Position Paper. This presentation served as a springboard for discussions on the future trajectory of telemedicine within internal medicine.

Future Projects:

The WG remains committed to advancing the field of telemedicine in internal medicine through several different projects planned for the coming year like webinars, surveys, work on new position papers and collaboration with EFIM Academy.

The Telemedicine WG has played a pivotal role in driving the advancement of telemedicine in internal medicine and we look forward to continuing to be a leading force in this transformative area of healthcare.

The collaboration with the American College of Physicians is ongoing and we are completing the Joint Position Paper on Telemedicine.



Ultrasound Working Group

Chair: João Neves

During 2023, the EFIM's Ultrasound Working Group, completed the Questionnaire about Point of Care Practice across all member societies. The results were presented at ECIM 2023, in Athens Greece, by Dr. João Neves, at the Parallel Session: Round Table Ultrasound. On the same session, Dr. Juan Torres Macho present the lecture "Point of care ultrasound. A game changer for internists in its clinical practice" and Prof. Frank Bosch the lecture "Point of care ultrasound training and implementation at Internal Medicine Departments".

Also at ECIM 2023, 3 Pre-Conference Workshop were organised: ABC of Lung Ultrasound; Basic Abdominal Ultrasound and Ultrasound for sarcopenia and obesity diagnosis.

Dr. Juan Torres Macho also took part of ESIM 2023 organising the "Basic Ultrasounds for residents" workshop.







MEETING OF THE HEALTH TECHNOLOGY ASSESSMENT STAKEHOLDER NETWORK



Summary report

The inaugural meeting of the Health Technology Assessment Stakeholder Network took place in Brussels on 14 June 2023. The meeting marks the creation of a formal stakeholder body under the Health Technology Assessment Regulation (EU) 2021/2282 (hereafter "Regulation"). 59 representatives from 43 stakeholder member organisations and two observer organisations participated. There were also representatives from 16 Member States, including the Chair and Co-Chairs of the Coordination Group as well as Chairs and Co-Chairs of the four sub-groups of the Coordination Group. The European Medicines Agency (EMA) was also present.

EUROPEAN COMMISSION

Directorate-General for Health and Safety

The meeting was chaired by the European Commission, Maya Matthews, Acting Director of Digital, EU4Health and Health Systems Modernisation Directorate in DG SANTE. EFIM was represented by Dr. Filomena Pietrantonio from FADOI Italy. The meeting started with an interactive introduction session. The stakeholders selected to be part of the Stakeholder Network represent a rich blend of patient organisations, payer organisations, learned societies, health professional organisations, health technology developers and other non-governmental organisations. Second meeting is planned for the end of the year.

EUROPEAN MEDICINES AGENCY

The European Federation of Internal Medicine is among the Scientific Societies selected by the European Medicines Agency (EMA) and invited to join the Healthcare Professional Working Party (HCPWP). The objective of this Working Party is to create a twoway dialogue between EMA and a selected group of organizations of healthcare professionals, so that EMA can collect inputs and transmit information on its activities and strategies in a more structured way. In many cases the activities of this Working Party



are associated with those of the Patients and Consumers Working Party (PCWP).

The main topics covered in 2023 concerned revision of the pharmacological legislation, antimicrobial resistance, regulatory and scientific aspects related to RNA-based medicines, development and evaluation of medicines for children, frail and older people in medicine development and evaluation, the issues related to drug shortages resulting from the difficult international political and economic situation, patient involvement in medicines development and regulation, the ongoing review of the Good Clinical Practice for clinical trials, Real World Evidence / Health Technology Assessment for regulatory purposes, and big data.

Overall, in 2023 the EFIM representative participated in 8 meetings (remote or at the EMA headquarters in Amsterdam), part of which concerned a parallel initiative to which EFIM adhered: the EMA eligible healthcare professional organizations' policy officers group (HCP POG). As a specific project, EMA asked EFIM for an expert opinion (performed by Prof. Mangoni) useful for the regulatory process of a drug in the evaluation phase at the Agency.

At the conclusion of my assignment as EFIM representative at EMA / HCPWP, I would like to thank the EFIM for the opportunity that was offered to me, and in particular Prof. Daniel Sereni with whom I shared this role for the first 3 years of my five-year mandate.

EARLY CAREER SUBCOMMITTEE REPORT

Chair: Frauke Weidanz



The aim of the EFIM Early Career Group is to bring together specialists in Internal Medicine from across Europe who want to develop their professional skills, and to organise networking and educational activities aimed primarily at newly appointed specialists in Internal Medicine. As the Subcommittee only has five members, we have been working on building a wider group of Early Career Internists around the committee and have started to involve them in our monthly video conferences and our activities, and we finally met some of them face to face during ECIM 2024.





For now, the Early Career Group will form a loose, informal structure around the subcommittee. We contacted all EFIM member societies asking for representatives to collaborate with us, and to build links with national Early Career or recently appointed specialist groups. Please let us know if you or a colleague wishes to work with us!

Our activities during ECIM 2023 in Athens were somewhat hampered by doctors' strikes in the UK and air-traffic control strikes in Greece, and three of our speakers were unable to attend the congress. In place of the planned sessions, we therefore organised a discussion round on learning, teaching and assessing soft skills in Internal Medicine. Thanks to the large and very engaged audience, this proved very popular and thought provoking, and ultimately inspired the design of the Early Career pre-congress course during ECIM 2024! The congress in Athens also saw the second edition of our "Celebrating Joy in Internal Medicine Award, which is designed to inspire and promote projects on teamworking, workplace culture and physician wellbeing in Internal Medicine. Out of around 70 applications, we shortlisted 6 for poster discussion

and invited the three highest scoring authors to deliver an oral presentation in our award session. The excellent and very creative projects of our finalists included a wellness-supporting mini-grants programme, an educational programme in hyponosisbased communication techniques for healthcare professionals, and a programme of mentorship and online wellbeing resources for medical students.

As every year, Early Career subcommittee members contributed to the programme of the summer edition of ESIM, and we once again organised the European Advanced School of Internal Medicine, this time in Bratislava (see separate report). The next edition of EASIM is in planning and will take place on December 6th - 8th, 2024.

EUROPEAN ADVANCED SCHOOL OF INTERNAL MEDICINE 2023

Following the successful courses held in Riga, Latvia since 2018, the EFIM Early Career Group has collaborated with the Slovak Society of Internal medicine to organise the 5th European Advanced School of Internal Medicine (EASIM) in Bratislava, Slovakia. The event was directed by Dr. Ieva Ruža and was held from 3-5 November 2023.

A small-scale international course is tailored to address the gap in postgraduate training for Early in Career internists in Europe. The EASIM format is based on the well-proven concept of the ESIM course for residents, but it is shorter and designed to meet the specific needs of recently appointed specialists in Internal medicine and its subspecialties. This year the Advanced School in Bratislava gathered 16 brilliant young specialists from 8 countries.

During the course, participants were provided with clinical updates through the "learn and teach" concept. Complicated clinical cases were also discussed, alongside hot topics in cardiology, endocrinology, and critical care. Attendees had the opportunity to discuss various ethical challenges and time management. Workshops were also conducted to help develop non-technical skills, such as communication, conflict management, giving feedback, and leadership skills. Despite a packed educational program, the group managed a short walking tour to Bratislava Castle and continued friendly networking during breaks.

We are sincerely grateful to Slovak Society of Internal medicine for organising this event, to the EFIM faculty for the brilliant lectures and especially we would like to thank the EASIM participants for their active participation who made this event possible.

FOUNDATION FOR DEVELOPMENT OF INTERNAL MEDICINE IN EUROPE



In continuity with a 20-year tradition, the Foundation for the Development of Internal Medicine in Europe (FDIME) has supported several actions in favor of Young Internists. FDIME also confirmed its commitment to transmit information on health issues to the public.

A 17 500 euros FDIME research grant has been attributed to Doctor Laure Galley from France. She will study the role of skeletal muscle stem cells in the pathogenesis of inflammatory myositis at the University Hospital of Geneva. The FDIME has provided a 3000 euros support to the EFIM Young Internists Exchange Program. During ECIM 2023, the Foundation has supported the three best research summaries prizes. The

20th annual Clinical Research Seminar was organized in Paris from 14 to 16 November. From the 51 applicants (a record number) ,15 coming from 10 different countries were selected. This "master class "in clinical research benefits from the generous participation of academic experts in clinical research and covers various aspects of Internal Medicine. The Seminar was highly evaluated by the participants. It is important to note that all

expenses are covered by the FDIME independently from any industrial source.

Encouraged by the success of the Covid-19 Newsletters, the FDIME has diversified its information activities to the patients and the public. During the year, 16 Newsletters and Health Communications on various subjects have been published on the website and on Facebook. Finally, a collaborative FDIME-EFIM session dedicated to the dialogue between Internists and patients has been successfully organized during ECIM in Athens.



FELLOWSHIP 2023

During the Joint European Congress of Internal Medicine (ECIM) 2023, held in conjunction with the International Congress of Internal Medicine, in Athens, Greece we have organised the 2nd official Fellowship Ceremony. A formal event recognizing the achievements and contributions of outstanding members in the field of internal medicine. This ceremony took place during the Opening Ceremony of the congress on 15 March, celebrating both new and invited fellows of EFIM.

During the ceremony, 13 distinguished EFIM members from 6 different national societies were conferred the title of EFIM Fellows. This honour is a testament to their exceptional contributions to the field of internal medicine, including clinical practice, research, education, and professional service.

EXCHANGE PROGRAMME REPORT

EFIM successfully re-launched the Exchange Programme in 2023. This initiative, which had been on hold due to the global pandemic, aims to foster international collaboration and professional development among young internal medicine residents across Europe.

The re-launched programme received very high interest, evidenced by 13 applications from six different national societies including Poland, Italy, Germany, Turkey, Algeria and North Macedonia.

Out of the 13 applicants, 6 residents successfully completed the exchange programme. These residents were placed in various internal medicine hospital centers across Europe, where they gained invaluable clinical experience and exposure to different healthcare systems.

The participating hospital centers, provided a supportive and educational environment for the exchange residents including Hospital de Cascais in Portugal, Campus Biomedico University Hospital in Rome, Fondazione Policlinico Universitario A. Gemelli in Rome, The Málaga Regional University Hospital, University Hospital Frankfurt Am Main in Germany, Centro Hospitalar Universitario de Santo Antonio in Porto in Portugal and several others. Each center facilitated the professional growth of the residents by integrating them into their clinical teams, involving them in the daily rounds and discussions, presenting them to innovative medical practices and research.

The feedback from both the residents and the host institutions was tremendously positive. The residents reported significant professional and personal development, citing the exchange as a fundamental experience in their careers.

YOUNG INTERNISTS SECTION REPORT

The Young Internists' Assembly is formed of 34 representatives from 25 countries members of EFIM. The aim of the group is to develop common educational projects, to consolidate collaborations and to improve the programs dedicated to the internists in training across Europe.



Webinars

In 2023 we organized five webinars covering different topics of high interest in Internal Medicine, such as Systemic Lupus Erythematosus, POCUS, Community Acquired Pneumonia, Systemic Sclerosis, and Pulmonary Hypertension.

All webinars had over 100 live participants, and each reached over 200 views on the EFIM YouTube channel. The Challenges in 2023 for Systemic Lupus Erythematosus webinar was the most accessed on YouTube, surpassing 4000 views.

In November 2022 we launched the Challenges in Internal Medicine survey, covering a broad spectrum of issues such as the workload, clinical skills and theoretical knowledge, soft skills, stress and burnout, ultrasound, and future perspectives. We gathered 512 responses from over 25 countries. The main challenges were the heavy workload, insufficient guidance and mentorship, need for ultrasound training, work-related stress. Results of the survey were presented during the ECIM 2023 and will be published in 2024.

Young Internists sessions during European Congress of Internal Medicine 2023

596 young internists participated at ECIM 2023. The YIs Assembly organized

two parallel sessions: Challenges in Internal Medicine Training (Joint session with the Latin American Young Internists) and Life outside of medicine: tales of the Asclepius, the Muses and the Olympians, one pre-congress workshop: How to write and publish a paper, and four YIs corners during the coffee breaks: How to deal with Breaking Bad. News, When should we think about autoimmune disease?, What is the role of General Internal Medicine in 2023? Are we needed? and How to ace your case (report).



Collaborations

In 2023 we continued the partnership with the Argentinian and Latin American Young Internists, by having joined sessions during ECIM 2023, respectively the Argentinian National Congress of Internal Medicine 2023. Additionally, we made the first steps towards a collaboration with the European Young Nephrologists' Platform to develop joined webinars.

ESIM WINTER 2023



The winter school 2023 took place in the small village of Björkliden. Located in the very north of Sweden where the nature is all around and temperatures as low as -26 Celsius degrees. The school was arranged under the tutelage of the Swedish Society of Internal Medicine. The director of the school was Fredrik von



Wowern and the co-directors were Dr. Ieva Ruza and Dr. Kim Pettersson Fernholm. A total of 50 residents from 20 different countries attended and speakers from 13 different countries were invited. The Winter school was off to a rough start where all participants arrived in the middle of a blizzard and a power-cut. But it didn't stop the participants from being happy and excited or the program from starting, so after a few hours and improvised lectures without any digital equipment, the storm subsided, and the program continued as planned. The program was a balanced combination of lectures, workshops and several clinical case presentations held by the attending residents. The lectures focused on clinical topics relevant to the internist, but were also focused on soft skills, how to be a good doctor and how to handle the many complex situations you might face as a clinician. The program also included a workshop in point of care ultrasound and a workshop in how to present science. The social program included a lecture in northern lights and how to dress in a cold climate followed by a guided tour to see the northern lights. The program also included winter bathing followed by a sauna experience, a walking tour called "winter wonderland" where the participants were taught how to build an igloo and ski school for cross country and alpine skiing. During the evenings there was karaoke and salsa lessons. The last night the participants presented something from their own countries to each other, followed by a gala dinner to end a wonderful week. The participants made friends for life and the overall experience was magical. We are grateful to be able to host winter school and we are looking forward to arranging it again next year!

EFIM ACADEMY





EFIM Academy offers an interactive, case-based learning experience in different fields of internal medicine and is freely accessible for all healthcare professionals. The year 2023 has been an efficient year in terms of updating the technical capacity of the platform and expanding the content in various ways.

A total of 17 modules have been released in addition to the episodes of the COVID-19 and basic clinical ultrasonography courses. Basic ultrasonography course aims to provide the basic theoretical knowledge to internists and residents who will pursue with hands-on courses. A new section namely 'One-minute learning' dedicated to rapid, visual learning has been launched. Not only web based learning but also podcasts that could be downloaded from several platforms provide a flexible learning experience.
